During inspection of business premises, M/S Rasheed medical store takhte nasrati Karak Distt:Karak,on dated:25/02/2016, Cough Syrup: Kufcure 120ml batch no: K 0372, was taken on Form-5 by the Drug Inspector Muhammad irfan wazir for the purpose of test & analysis. Sealed portions of sample of said product were distributed by as per law (copies attached). Reference to the letter No: 25/PDI/Karak, dated: 26/02/2016, The Govt: Analyst Provincial Drugs Testing Laboratory KP Peshawar has declared the said product to contain allopathic ingredients and unregistered vide Test & Analysis report i.e TRA No:39352/ DTL dated: 19/04/2016.(DTL Report Enclosed).Rasheed medical store was served upon show cause notice (Copy Attached) in order to explain his position regarding this contravention to which he replied and disclosed haroon enterprises bannu via invoice # 223986, dated : 20/02/2016). To investigate the case further, Haroon enterprises bannu was served upon show cause notice (Copy Attached) in order to explain his position regarding this contravention to which he replied and disclosed city herbal care laboratories Karachi as the supplier via invoice # 16-78220, dated: 06/02/2016. Finally, to city herbal care laboratories Karachi was served upon show cause notice (Copy Attached) in order to explain his position regarding this contravention to which he did not reply. The case was then referred to the Chairman Provincial Quality Control Board, Khyber Pakhtunkhwa Peshawar vide letter no: 52/pqcb/kk and dated 29/08/2016 for scrutiny and seeking guidance for further necessary legal action to be taken against him. The case was heard & discussed in PQCB KPK Peshawar in its 298 th PQCB Committee meeting, held on 04/09/2018, the minutes of which were received to me on 10/03/2019, in which PQCB KPK has directed me to refer the case to Drug court for judicial trial of the accused. So in light of directions of PQCB, I submit a complaint against above name accused. The accused has contravened the provision of section 23 (1) (a) (vii) and 23(1)(b) of The Drugs Act 1976. It is therefore requested that he may be punished under Section 27 of the Drugs Act 1976.
